Approval is subject to the condition that the management of the School shall follow the below norms -

- I. **Seek renewal of all FOCs after their expiry prescribed in terms of SRQ 123,**
- II. Notify in a leading news papers the details of the fee structure before commencement of each academic session.
- III. Verify along with fee, without approval of competent authorities.
- IV. Pay reasonable salary to the teachers and other staff as per Minimum wages Act and payment thereof shall be made only through cheque.
- V. The salary structure so allowed shall be duly notified, along with other service conditions including inter alia matters of CF, fund leave of different kinds Pension Gratuity etc as the case may be.
- VI. Arrange regular in service training to teachers including orientation and refresher Courses on the basis of actual need from time to time.
- VII. Institute an appropriate mechanism to ensure that salaries of teachers or other staff are not dispersed with or withheld without due regard to the principles of equity and fair pay. Disciplinary action or proceedings if any, shall be initiated and shall be conducted consistent with the due process of law and also notified to the FOC/ZFO concerned.
- VIII. Deposit with the respective office one share subscription on account of Games - Red cross fund in terms of the orders - instructions in force.
- IX. Furnish correct and complete information as per format provided to CEO/ZEO concerned for updation of District Information System of Education (DISSE) and Education Management Information System (EMIS) and also proper affidavit as per.

Any deviation or default in adherence to the norms/rules laid down and the orders / instructions issued from time to time shall render the School liable for strict action which may include withdrawal of recognition, besides other penal action under law rules.
